

A mothers room was built onto the Sharon church in the year 1916. - Gost Yoder Contractor - Cost of building \$178.

A parsonage was built in the year 1917. at a cost of \$3876.68. The old parsonage was sold for \$247.00 to a Mr. Pfeiffer of Kalonada. A meeting was held in June to consider building or remodeling. A Committee was of three was appointed namely L. P. Warner U.S. Niffenegger and D. L. Troyer. to take matter up with those interested. Another meeting was ~~was~~ held in July (2nd) at this meeting a large number of members were present and \$2400.00 were raised. Noah Yoder started the subscriptions with a \$100.00 subscription. A little later R. B. Jones, Don Yoder & Noah Yoder were selected as Building Committee & J. T. Windham as Treasurer with Walter Weber & H. Kesseling as his assistants. R. B. Jones was chosen as Superintendent. The latter part of Aug the building operations began and the building was completed and moved into by the 23rd of December of 1917. The dedication service took place the 22nd of March 1918. with no indebtedness. Windham furnished the major part of the program Mrs. F. Weber & Mrs. E. Yoder sang a duet with the choir joining in on the chorus. Ester & Jella Crow sang three duets and then, Raymond and Lloyd Crow played the accompaniments on the ^{two} guitars & a violin. Sharon Octet also sang. The Pastor Rev. Geo. J. Prothro addressed the people briefly. Prayer, & P.S. 84. was read. The Dedication ritual & form was then read. Earl Miller also addressed the people speaking of the building and the valuable service rendered by R. B. Jones and presented the lotter with a purse of \$50.00. The Pastor was also present with \$27.50. This address was furnished by D. Yoder. & Miller then presented the America & Donalogue were then sung. and benediction given. This closed this beautiful service. The parsonage stands as a monument to the thrift & fellowship of the two communities. namely Windham & Sharon. Mrs. Kimmel the Deaconess of Iowa City lit up the parsonage with electricity which helped to make the evening more pleasant. G. J. Prothro pastor.

A Cemetery Fence was also put in at Sharon. at a cost of \$3.50 ~~or~~ ^{and} 1917.

At Kindham the church was raised and a bema put under same. a furnace installed by Social Circle. the circle raised sufficient money to buy a Piano and fix up interior such as pointing new paper - new matting & new curtains. The improvements including donations work represent of about \$1000.00 or perhaps close to \$1100.00 - this work started in 1916 & was finished in 1917 Oct when it was resealed & the ~~fall~~ Bishop Swengel. There was a deficit of 3% & before day was over over \$400.00 were raised.

During the conference year of 1935-36 the pastor began holding regular preaching services at the Windham Church at 9 A.M. (later 9:30 A.M.) each Sunday. Previous to this time services had been held on alternate Sundays the Sunday school and other work had been discontinued completely. In Sept. 1935 the Sunday school was reorganized. In the same month, somewhat earlier, a Ladies Aid was organized. In April 1936 an E. L. C. E. was organized with 19 charter members.

In the Fall of 1936 the walls and ceiling of the Windham Church were redecorated, including Ceiling Board, Paper and Paint, at a cost of \$114.59 in cash with considerable contributed labor. This project was sponsored by the Ladies aid assisted by the E. L. C. E. Before the close of the conference year the crumbling floor in the Windham church basement was removed and some funds raised by the E. L. C. E. toward a remodeling of the basement. Nine adult members were received into the Windham congregation on Easter Sunday, 1937. Ten new members were received into the Sharon congregation the same spring. General finances on the field have considerably improved during the past two years though there is still need for further advance along this line.
