Defiance - David Brian Glenn, son of Robert and Catherine Cronin Glenn was born at Jefferson Sept. 5, 1956. He was baptized at Gladbrook. He attended school in Lamont, Anamosa, Gladbrook and graduated at Harlan in 1974. He later attended college at Iowa Western Community College and Buena Vista University at Storm Lake attaining an Associate of Science degree in Business Mid-Management and a Bachelor of Science degree in accounting. He entered the United States Army in 1975, and held the rank of Staff Sergeant upon his discharge in 1985. He was an Aerial Sensor Specialist while in the service and was awarded the Army Commendation Medal, Army Achievement Medal, Army Good Conduct Medal (2nd Awd), NCO Professional Development Ribbon, Army Service Ribbon and Overseas Service Ribbon for his service in Korea. After his discharge from the U.S. Army, he was employed as a communications specialist with Bell Technical Operations, Inc. in Sierra Vista, AZ. He spent a year employed by Morrison-Knudsen Services, Inc. at Fort Huachuca, AZ before coming to Harlan and being a data entry operator at Communications Data Services. He then became an employee of Hy-Vee Food Stores, Inc. in Harlan as a night crewman and was later promoted to a non-foods manager.

Sept. 20, 1978 he married Tae Seon Lee in Seoul, Korea. To this union six children were born. The family now makes their home in Defiance. He was a former member of Sierra Vista Baptist Church in Sierra Vista, AZ, and a member of the Bethel Baptist Church in Harlan. He died April 18, 1996 at Myrtue Memorial Hospital at age 39 years, seven months and 13 days. Surviving are his wife, Tae Glenn of Defiance; his children Christine, age 17, Matthew, age 15, Jennifer, age 12, Jonathan, age 11, Rebecca, age 7 and Andrew Glenn, age 4; his parents Robert and Catherine Glenn of Grand Junction; his brothers and sisters, Mark Glenn (Trish) of Albuquerque, NM; Marcia (Mark) Winder of Mt. Vernon, MO; Joel Glenn (Mary) of Ames, Gary Glenn (Sara) of Fort Wayne, IN, Sharon (Randy) Kroger of Harlan, and Michael Glenn (Deb) of Omaha, NE; his maternal grandmother Doris Cronin of Ankeny and other relatives.

Funeral services were held April 22, 1996 at Bethel Baptist Church in Harlan with Rev. Roger Crawford officiating.
