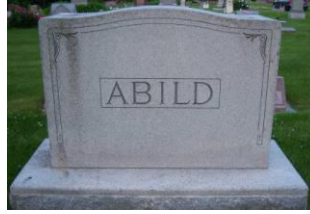

Last Will and Testament

I Samuel Abild, being of sound mind and disposing memory and aware of the uncertainty of life do make and publish this my last will and testament hereby revoking all former wills by me at any time made.

I give, devise and bequeath all the property I may own at the time of my death, as follows, to wit:

Par. 1. To my wife, Christina Abild, to be held by her in trust for my daughter, Hannah Abild, the sum of \$2000.00 and should my wife refuse to act or be incapacitated I desire my oldest son, Chris H. Abild act as such trustee with the power to nominate his successor. And said Chris H. Abild or Christina Abild as trustees to hold said property and pay the income therefrom and as much of the principal as they may think proper to the said Hannah Abild for her care and sustenance but said trustees shall be relieved from the giving of any bond and from the necessity of reporting to any court of their doings as to said trust.

Par. 2. To my sons, Chris H. Abild, Joe Abild, John Abild and Russell Abild I give the sum of \$5.00 each. And to my daughters, Caroline Abild Sherwin and Bernice Abild the sum of \$5.00 each.

Par. 3. All the rest, residue and remainder of my property of whatsoever kind and description whether real personal or mixed and wheresoever located I give, devise and bequeath to my beloved wife, Christina Abild, to be hers absolutely and in fee.

Par. 4. I hereby nominate my wife, Christina Abild, to be the Executrix of this my last will and testament and I desire that she be allowed to act as such without the necessity of giving bond.

In witness whereof, I have to this, my last will and testament, consisting of one sheet of paper, subscribed my name this 25<sup>th</sup> day of July A. D. 1925.
